

Representative District 74 shall include that part of Illinois beginning at the intersection of County Rd. 00 and Old Sage Rd. in Fairfield Twp. in Bureau County, thence east to the Greenville Twp. line, thence east to the Walnut Twp. line, thence east to the Ohio Twp. line, thence east and south following the Ohio Twp. line to the Dover Twp. line, thence south to the Princeton Twp. line, thence south, west and north following the Princeton Twp. line to US Hwy. 6 (Wyanet Twp.), thence west following US Hwy. 6 to South Maple St., thence south to East 2nd St., thence west to South Walnut St., thence south to East 3rd St., thence west to South Locust St., thence south to West 4th St., thence west to South Arch St., thence south to 5th St., thence west to County Hwy. 8, thence south following County Hwy. 8 to Wyanet-Walnut Rd., thence continuing south following Wyanet-Walnut Rd. to the Wyanet Twp. line (County Rd. 1200 N Ave.), thence west to the Macon Twp. line (County Rd. 1200 E St.), thence south and west following the Macon Twp. line to the Osceola Twp. line in Stark County, thence south to the Penn Twp. line, thence south to the Valley Twp. line, thence south and west following the Valley Twp. line to the Essex Twp. line, thence west to the West Jersey Twp. line (West Walnut Creek Rd.), thence west to the Truro Twp. line in Knox County, thence south to the Elba Twp. line, thence south to the Salem Twp. line, thence south and west following the Salem Twp. line to the Maquon Twp. line, thence west to the Chestnut Twp. line, thence west to the Indian Point Twp. line, thence west and north following the Indian Point Twp. line to the Cedar Twp. line, thence north to the Galesburg Twp. line, thence north to the Henderson Twp. line, thence north to the Rio Twp. line, thence north to the Oxford Twp. line in Henry County, thence north and east following the Oxford Twp. line to the Clover Twp. line, thence east to the Cambridge Twp. line (East 1200th St.), thence north to the Munson Twp. line, thence north following the Munson Twp. line to North 1500th Ave., thence east to East 1300th St., thence south approximately 28,854 feet following East 1300th St. to the district boundary, thence east approximately 15,149 feet following the district boundary to Il. Rt. 82,

thence north to County Rd. 14,
thence east to East 1500th St.,
thence north to North 1500th Ave.,
thence east to East 1600th St.,
thence north and northeast following East 1600th St. to the Munson Twp. line (North
1800th Ave.),
thence east to the Cornwall Twp. line,
thence east to the Annawan Twp. line,
thence east to the Gold Twp. line in Bureau County,
thence north to the Fairfield Twp. line,
thence north, west and north following the Fairfield Twp. line to the place of beginning.
