thence east to the Stephenson County line,  
thence east to the Winnebago County line,  
thence east to the Boone County line,  
thence east to the McHenry County line,  
thence east to the Alden Twp. line,  
thence south to the Grafton Twp. line,  
thence east to the Nunda Twp. line,  
thence north approximately 37,406 feet following the Nunda Twp. line to the district boundary,  
thence east approximately 25,174 feet following the district boundary to Walkup Rd.,  
thence south to Pleasant Hill Rd.,  
thence southeast to Bay Rd.,  
thence southeast to Half Mile Turn,  
thence northeast to the Crystal Lake Corp. limits,  
thence southeast, east, northeast, south, west, south, west, south and east following the Crystal Lake Corp. limits to the Barreville Rd.,  
thence southwest to the Crystal Lake Corporate limits,  
thence northeasterly to Il Rt. 176,  
thence northeasterly following Il Rt. 176 to Behan Rd.,  
thence east to Buhl Rd.,  
thence south to Behan Rd.,  
thence east following Behan Rd. to Behan Rd. extended,  
thence northeast, southeast and northeast following Behan Rd. extended to Giant Oak Dr.,  
thence southeast to Porten Rd,  
thence east, south and east following Porten Rd. to Roberts Rd.,  
thence southeasterly to the Nunda Twp. line,  
thence south to the Algonquin Twp. line,  
thence south to the southeast corner of the Algonquin Twp. line (McHenry County line),  
thence west following the McHenry County Line to the northeast corner of DeKalb County,  
thence south, west and south following the DeKalb County line to the southeast corner of Sycamore Twp.,  
thence west to Il Rt. 64,  
thence northwesterly following Il Rt. 64 to East State St.,  
thence west to the Sycamore Corp. limits,  
thence south, west and north following the Sycamore Corp. limits to East State St.,  
thence west to the E Branch S Br Kishwaukee River,  
thence northerly following the E Branch S Br Kishwaukee River to Hopkins Lane,  
thence northerly to the Sycamore Corp. limits,  
thence east and north following the Sycamore Corp. limits to Mount Hunger Rd.,  
thence southeasterly to Sycamore Corp. limits,  
thence north, west, south, west, south and northwest following Sycamore Corp. limits to Il Rt. 23,

thence southwesterly following Il Rt. 23 to Maplewood Drive,  
thence west to Brickville Rd.,  
thence north to West Brickville Rd.,  
thence west and northwesterly following the West Brickville Rd. to the Sycamore Corp. limits,  
thence south, west, south, northwest, west and south following the Sycamore Corp, limits to Freed Rd.,  
thence westerly to Peace Rd.,  
thence southwesterly to Il Rt. 64,  
thence northwesterly following Il Rt. 64 to the Mayfield Twp. line,  
thence south to the southeast corner of Mayfield Twp.,  
thence west to the northeast corner of Malta Twp.,  
thence south to the southeast corner of Malta Twp.,  
thence west to the Dement Twp. line (Ogle County)  
thence west following the Ogle County line to the Whiteside County line (Jordan Twp.),  
thence south to the Rock River,  
thence generally northwest approximately 9,715 feet following the Rock River to the district boundary,  
thence southwest approximately 1,053 feet following the district boundary to Harbor Drive,  
thence northwesterly to Island View Dr.,  
thence northwest and southwest following Island View Drive to Dixon Rd.,  
thence northwesterly to the Rock Falls Corp. limits,  
thence north, west, north, east and north following the Rock Falls Corp. limits to Minkel St.,  
thence west approximately 130 feet following Minkel St. to the district boundary,  
thence north approximately 348 feet following the district boundary to the Rock Falls Corp. limits,  
thence west following the Rock Falls Corp. limits to Martin Rd.,  
thence south approximately 340 feet following Martin Rd. to the district boundary,  
thence west approximately 100 feet following the district boundary to the Rock Falls Corp. limits,  
thence west, south, east and south following the Rock Falls Corp. limits to Lincoln St.,  
thence west to Emmons Ave.,  
thence northwesterly to East Second St.,  
thence northwesterly to the Hennepin Canal Feeder,  
thence northeast approximately 1,176 feet following the Hennepin Canal Feeder to the district boundary,  
thence northeast approximately 2,037 feet following the district boundary to the Coloma Twp. line,  
thence northeast and east following the Coloma Twp. line to Freeport Rd. extended,  
thence north to Freeport Rd.,  
thence continuing north following Freeport Rd. to East LeFevre Rd.,  
thence west to 19<sup>th</sup> Ave.,  
thence north to the Sterling Corp. limits,  
thence north and west following the Sterling Corp. limits to East Lynn Blvd.,

thence northwesterly to the Sterling Corp. limits,  
thence north and west following the Sterling Corp. limits to 6<sup>th</sup> Ave.,  
thence north to Science Ridge Rd.,  
thence west to the Sterling Twp. boundary,  
thence north to the southeast corner of Genesee Twp. (Fulfs Rd.),  
thence west to the northeast corner of Mount Pleasant Twp.,  
thence south to the southeast corner of Mount Pleasant Twp.,  
thence west to the Union Grove Twp. line (Mellotts Rd.),  
thence west to the northeast corner of Newton Twp.,  
thence south to the southeast corner of Newton Twp.,  
thence west to the Newton Twp. line,  
thence north to the Garden Plain Twp. line,  
thence north to the Whiteside County line,  
thence northerly following the Whiteside County line to the Carroll County line,  
thence northerly following the Carroll County line to the JoDaviess County line,  
thence northwesterly following the JoDaviess County line to the place of beginning.
