


Illinois Representative District 15

Representative District 15

(Entirely within Cook County):

Representative District 15 shall include that part of Illinois beginning at the intersection of E. Central Rd and Dee Rd between Glenview and Niles in Cook County, thence east along E. Central Rd to Lehigh Av, thence continuing east for approximately 250 feet along Central Rd (extended) to the Soo (Amtrak) rail line, thence southeast along the Soo (Amtrak) rail line (and the rail line right-of-way) to Golf Rd, thence east along Golf Rd to Normandy Av, thence south along Normandy Av to Beckwith Rd, thence east along Beckwith Rd to the Chicago River North Branch, thence south along the Chicago River North Branch for approximately 1900 feet, thence south and southwest for approximately 2400 feet to Dempster St, thence east along Dempster St to Narragansett Av, thence south along Narragansett Av to Hennings Ct, thence east along Hennings Ct to Ferris Av, thence north along Ferris Av to Dempster St, thence east along Dempster St to School St, thence south along School St to Crain St, thence east along Crain St to the west alley between School St and Austin Av, thence south along the west alley between School St and Austin Av to the alley between Crain St and Capulina Av, thence east along the alley between Crain St and Capulina Av to the east alley between School St and Austin Av, thence north along the east alley between School St and Austin Av to Crain St, thence east along Crain St to Austin Av, thence south along Austin Av to Oakton St, thence east along Oakton St to Luna Av, thence south along Luna Av to Kirk St, thence west along Kirk St to Central Av, thence south along Central Av to Mulford St, thence east along Mulford St to Linder Av, thence south along Linder Av to Harvard Terrace, thence west along Harvard Terrace to I-94 Frontage Rd, thence southeast along I-94 Frontage Rd to Howard St, thence west along Howard St (extended) to I-94, thence southeast along I-94 to Touhy Av, thence west along Touhy Av to approximately 30 feet east of N. Central Av, thence south approximately 1050 feet, running parallel to N. Central Av, thence west approximately 30 feet to N. Central Av, thence south along N. Central Av to its' terminus, thence east for approximately 1550 feet along the service road to Carpenter Rd, thence south along Carpenter Rd to W. Pratt Av, thence east along W. Pratt Av to N. Navajo Av, thence south along N. Navajo Av to N. Sauganash Av,

thence southeast along N. Sauganash Av to N. Navajo Av,

thence northwest along the Soo (Amtrak) rail line to a point approximately 100 feet north of W.
Seminole St (extended),
thence west for approximately 100 feet,
thence south for approximately 100 feet to W. Seminole St,
thence west along W. Seminole St for approximately 250 feet,
thence north for approximately 250 feet,
thence northwest for approximately 200 feet to N. Indian Rd,
thence northwest along N. Indian Rd to N. Central Av,
thence north along N. Central Av to the Chicago River North Branch,
thence generally west, north, and west along the Chicago River North Branch to W. Devon Av,
thence west along W. Devon Av to N. Nagle Av,
thence south along N. Nagle Av to W. Palatine Av,
thence west along W. Palatine Av to N. Natoma Av,
thence north along N. Natoma Av to W. Devon Av,
thence west along W. Devon Av to N. Normandy Av,
thence north along N. Normandy Av to W. Albion Av,
thence west along W. Albion Av to N. Newcastle Av,
thence south along N. Newcastle Av to W. Hayes Av,

thence north along N. Harlem Av to W. Howard St,
thence east along W. Howard St to N. Waukegan Rd,
thence north along N. Waukegan Rd to a point approximately 540 feet north of W. Oakton St,
thence west approximately 1180 feet to N. Harlem Av,
thence north along N. Harlem Av to W. Monroe St,
thence west along W. Monroe St to N. O'Dell Av,
thence north along N. O'Dell Av to W. Main St,
thence west along W. Main St to N. Oriole Av,
thence north along N. Oriole Av to W. Greenleaf St,
thence west along W. Greenleaf St, and continuing west along W. Greenleaf St (extended) , and
continuing west along W. Greenleaf St to N. Ozanam Av,
thence south along N. Ozanam Av to N. Milwaukee Av,
thence southeast along N. Milwaukee Av to W. Main St,

Church St to Dee Rd, thence north along Dee Rd to Hollyberry Av (extended), thence east along Hollyberry Av (extended), and continuing east along Hollyberry Av, and continuing east along Hollyberry Av (extended) to Hamlin Av, thence north along Hamlin Av to W. Emerson St, thence east along W. Emerson St to N. Parkside Av, thence north along N Parkside Av to W. Kathy Ln, thence east along W. Kathy Ln to N. Western Av, thence north along N. Western Av for approximately 320 feet, thence west for approximately 1330 feet to the intersection of Sherry Ln and Hamlin Av, thence north for approximately 150 feet, thence northwest for approximately 135 feet, thence north for approximately 450 feet to W. Golf Rd, thence west along W. Golf Rd to N. Dee Rd, thence north along N. Dee Rd to Harrison St, thence west along Harrison St to N. Dee Rd, thence north along N. Dee Rd to the point of beginning.
