


Illinois Representative District 45



Representative District 45

(Partially within Cook and Dupage Counties)

Representative District 45 shall include that part of Illinois beginning at the intersection of US 20 / Ulysses S. Grant Memorial Hwy and Naperville Rd (at the Streamwood and Bartlett border in Cook County),

thence southeast along US 20 / Ulysses S. Grant Memorial Hwy to a point approximately 150 feet west of the westbound entrance ramp of US 20 / Ulysses S. Grant Memorial Hwy from IL Rt 59,

thence east to a point approximately 50 feet along the westbound entrance ramp of US 20 from IL Rt 59,

thence southwest along the westbound entrance ramp of US 20 / Ulysses S. Grant Memorial Hwy from IL Rt 59 to US 20 / Ulysses S. Grant Memorial Hwy,

thence east along US 20/W. Lake St

thence continuing east along W. Lake St to E. Lake St,

thence continuing east along E. Lake St to Wayne Ct (extended),

thence south along Wayne Ct (extended) and continuing south along Wayne Ct to E. Taylor Av,

thence east along E. Taylor Av to N. Hale Av,

thence south along N. Hale Av to E. Morse Av,

thence east along E. Morse Av to N. Prospect Av,

thence south along N. Prospect Av to S. Prospect Av,

thence south along S. Prospect Av to the Soo rail line,

thence southeast along the Soo rail line for approximately 3950 feet,

thence south for approximately 505 feet to Devon Av,

thence west for approximately 20 feet,

thence south for approximately 275 feet,

thence west for approximately 160 feet,

thence south for approximately 2610 feet,

thence east for approximately 2475 feet,

thence south for approximately 360 feet,

thence east for approximately 415 feet to County Farm Rd,

thence south along County Farm Rd for approximately 1370 feet,

thence east for approximately 250 feet,

thence southwest and southeast for approximately 65 feet,

thence northeast for approximately 75 feet,

thence east for approximately 100 feet,

thence south for approximately 600 feet to Greenbrook Blvd,

thence west along Greenbrook Blvd, and continuing west along E. Stearns Rd to the intersection of Redford Ln and E. Stearns Rd,

thence west and northwest for approximately 310 feet,

thence south for approximately 2670,

thence east for approximately 740 feet,

thence south for approximately 50 feet,

thence east for approximately 8800 feet across the Mallard Lake Forest Preserve to the intersection of Thorn Rd and Foster Av,

thence east along Foster Av to Keeney Rd,

thence north along Keeney Rd to W. Lake St,

thence southeast along W. Lake St to Summerfield Dr,

thence northeast along Summerfield Dr to Mensching Rd,
thence northwest along Mensching Rd to Forest Av,
thence northeast along Forest Av to 50 feet west of the east border of Section 9, T40N, R10E (3rd principal meridian),
thence north approximately 1100 feet to Heritage Dr,
thence north along W. End Rd (extended) to W. End Rd,
thence east along Byrn Mawr Av to Hill St,
thence north along Hill St to W. Ardmore Av,
thence east along W. Ardmore Av, and continuing east along W. Ardmore Av (extended), and continuing east along E. Ardmore Av to S. Prospect St,
thence north along S. Prospect St to E. Pine St,
thence west along E. Pine St to S. Roselle Rd,
thence north along S. Roselle Rd to W. Elm Av,
thence west along W. Elm Av and continuing west along Elm St to Hill St,
thence north along Hill St to Claria Dr,
thence east along Claria Dr to N. Roselle Rd,
thence north along N. Roselle Rd to E. Granville Av,
thence east along E. Granville Av to a point approximately 270 feet east of Ambleside Dr,
thence north northeast for approximately 1000 feet to a point on E. Devon Av which is approximately 250 feet east of Ambleside Dr,
thence southeast and east along E. Devon Av to a point approximately 120 feet east of Forum Dr,
thence north and northeast for approximately 70 feet,
thence southeast and south for approximately 70 feet to E. Devon Dr,
thence east along E. Devon Dr to N. Plum Grove Rd,
thence north along N. Plum Grove Rd to the Cook County border,
thence east running parallel and south of the Cook / Dupage County border to a point approximately 80 feet west of the intersection of Devon Av and Lively Blvd,
thence south for approximately 1700 feet to the intersection of Lively Blvd and Mark St,
thence continuing south along Lively Blvd to E. Thorndale Av,
thence east along E. Thorndale Av to Lively Blvd,
thence south along Lively Blvd to Richert Rd,
thence west along Richert Rd to N. Central Av,
thence south along N. Central Av to Foster Av,
thence east along Foster Av for approximately 60 feet,
thence south for approximately 870 feet to Elmhurst St,
thence west along Elmhurst St to N. Wood Dale Rd,
thence south along Wood Dale Rd to the Soo rail line,
thence east along the Soo rail line to Kingery Hwy,
thence south along Kingery Hwy to a point approximately 160 feet south of W. Wood Av,
thence west northwest for approximately 332 feet,
thence south along Pine Tree Ln (extended) and continuing south along Pine Tree Ln to Royal Oaks Dr,
thence east along Royal Oaks Dr to Kingery Hwy,
thence south along Kingery Hwy to Deerpath Rd,
thence west along Deerpath Rd to S. Central Av,
thence south along S. Central Av to Juniper Dr,
thence west along Juniper Dr and continuing west along Juniper Dr (extended) to the terminus of S. Cedar St,
thence continuing west along the Addison / Wood Dale municipal borders to S. Addison Rd,

thence north along S. Addison Rd to Dominion Dr,
thence west along Dominion Dr to S. Dominion Dr,
thence south along S. Dominion Dr to W. Dominion Dr,
thence west along W. Dominion Dr to S. St Andrews Dr,
thence north along S. St Andrews Dr to W. Dominion Ct,
thence southwest for approximately 450 feet,
thence south for approximately 710 feet to I-290,
thence northwest along I-290 to N. 3rd Av (extended)
thence south along N. 3rd Av (extended) and continuing south along N. Fischer Dr/3rd Av and N. 3rd Av
(extended) to the terminus of N. 3rd Av,
thence west for approximately 135 feet,
thence south for approximately 630 feet,
thence east for approximately 135 feet to N. 3rd Av,
thence south along N. 3rd Av to W. Lake St,
thence southeast along W. Lake St to N. Mill Rd,
thence south along N. Mill Rd to W. Army Trail Blvd,
thence west along W. Army Trail Blvd to a point approximately 60 feet west of N. Flora Pky,
thence north for approximately 1250 feet,
thence east for approximately 320 feet,
thence north for approximately 520 feet to the northeast corner of Section 30, T40N, R11E (3rd principal
meridian),
thence west along the north border of Section 30, T40N, R11E (3rd principal meridian) to N. Rohlwing
Rd,
thence north along N. Rohlwing Rd to E. Lake St,
thence west along E. Lake St to Glen Ellyn Rd,
thence south along Glen Ellyn Rd to a point approximately 210 feet south of Circle Av,
thence west for approximately 800 feet,
thence west southwest for approximately 500 feet,
thence west for approximately 900 feet,
thence west northwest for approximately 135 feet to Lakeview Ln,
thence southwest along Lakeview Ln for approximately 60 feet,
thence west for approximately 2800 feet to S. Bloomingdale Rd,
thence south along S. Bloomingdale Rd to the Glendale Heights / Bloomingdale municipal border,
thence west, and south along the Glendale Heights / Bloomingdale municipal border to E. Army Trail Rd,
thence west along E. Army Trail Rd, and continuing west along W. Army Trail Rd to approximately 100
feet west of the Wayne Twp border,
thence south approximately 3700 feet to Lies Rd,
thence continuing south approximately 1650 feet to Provicetown Dr,
thence west along Provicetown to Longmeadow Dr,
thence southwest along Longmeadow Dr for approximately 220 feet,
thence northwest for approximately 940 feet,
thence west for approximately 130 feet to the pond shoreline,
thence southeast, west, and north along the pond shoreline to a point approximately 175 feet north
along the west shoreline,
thence west for approximately 150 feet to the pond shoreline west of N. County Farm Rd,
thence continuing west along the pond shoreline to River Dr,
thence west along Shennandoah Dr to Ridge Trail,
thence south along Ridge Trail for approximately 240 feet,

thence west and south along the pond shoreline,
thence west for approximately 60 feet to Morton Rd,
thence north along Morton Rd to Big Eagle Trail,
thence west along Big Eagle Trail to a point approximately 150 north of Birchbark Trail,
thence west for approximately 4700 feet to Fair Oaks Rd,
thence south along Fair Oaks Rd to North Av,
thence west along North Av to the West Branch Dupage River,
thence south along the West Branch Dupage River to Hawthorne Ln (extended),
thence west along Hawthorne Ln (extended), and continuing west along Hawthorne Ln, and continuing
west along E. Hawthorne Ln to N. Neltnor Blvd,
thence northwest and north along N. Neltnor Blvd to Diversey Pky,
thence west along Diversey Pky to the trail between Wiant Rd and Mulberry Dr,
thence northwest along the trail between Wiant Rd and Mulberry Dr for approximately 6350 feet to the
intersection of Munger Rd and Smith Rd,
thence north along Munger Rd to Forest Preseve Dr,
thence east along Forest Preserve Dr to Woodland Hills Dr,
thence south along Woodland Hills Dr to Saddleridge Pl,
thence south and northeast along Saddleridge Pl to Woodland Hills Dr,
thence generally southeast and continuing northeast along Woodland Hills Dr to the north border of
Section 16 T40N, R9E (3rd principal meridian),
thence east along the north border of Section 16 T40N, R9E (3rd principal meridian) to Sutton Rd,
thence north along Sutton Rd to Auburn Ln,
thence east along Auburn Ln to Norfolk Av,
thence north along Norfolk Av approximately 520 feet,
thence west approximately 520 feet to Sutton Rd,
thence north along Sutton Rd to approximately 75 feet south of the Cook County border,
thence west approximately 920 feet to Naperville Rd,
thence northwest along Naperville Rd to the point of beginning.
