


Illinois Representative District 64



Representative District 64

(Partially within Lake and McHenry Counties)

Representative District 64 shall include that part of Illinois beginning at approximately 165 feet west of the intersection of Lakeview Rd in McHenry County and the Illinois / Wisconsin border, thence east along the Illinois / Wisconsin border to Il Route 83 (Main St), thence south along Main St to the Wisconsin Central rail line, thence southeast along the Wisconsin Central rail line to North Av, thence west along North Av to N. Tiffany Rd, thence south along N. Tiffany Rd to for approximately 920 feet, thence east for approximately 750 feet, thence south for approximately 600 feet, thence west for approximately 750 to N. Tiffany Av, thence south along N. Tiffany Rd for approximately 950 feet, thence west for approximately 1300 feet, thence south for approximately 1000 feet to W. IL Rt 173, thence west along W. IL Rt 173 to a point approximately 180 feet east of N. 1st Av, thence south for approximately 1500 feet to the south border of Section 12, T46N, R9E (3rd principal meridian), thence east along the south border of Section 12, T46N, R9E (3rd principal meridian) to approximately 85 feet east of the northwest corner of Section 18, T46N, R10E (3rd principal meridian), thence south running parallel to the west border of Section 18, T46N, R10E (3rd principal meridian) for approximately 1250 feet, thence east for approximately 4000 feet to IL Rt 59, thence south along IL Route 59 to Bowles Rd, thence west along Bowles Rd to Morning Dove Ln, thence south for approximately 1250 feet, thence east for approximately 2500 feet to IL Rt 59, thence south along IL Route 59 to W. Beach Grove Rd, thence west along W. Beach Grove Rd for approximately 1350 feet, thence south for approximately 1600 feet, thence west for approximately 950 feet, thence south for approximately 950 feet, thence east for approximately 950 feet, thence south for approximately 1300 feet to W. Grass Lake Rd, thence east along W. Grass Lake Rd to N. IL Route 59, thence south along IL Route 59 to W. Grand Av, thence east along W. Grand Av to an unnamed road approximately 330 feet west of N. Cedar Lake Rd, thence north along the unnamed road and continuing north along the unnamed road (extended) to the shoreline, thence continuing north across the lake and following the shoreline northeast to Rae Ln (extended), thence west along Rae Ln (extended) to Rae Ln, thence west along Rae Ln to N. Wilton Av, thence north along N. Wilton Av to W. North Av, thence northeast along W. North Av to N. Cedar Lake Way, thence north along N. Cedar Lake Way to a point approximately 50 feet south of W. Petite Lake Rd,

thence east to Belmora Park Blvd,
thence north along Belmora Park Blvd to W. Petite Lake Rd,
thence east along W. Petite Lake Rd to Milwaukee Av,
thence northwest along N. Milwaukee Av to W. Wall St,
thence east along W. Wall St to Wisconsin Central rail line,
thence south along Wisconsin Central rail line for approximately 500 feet,
thence east for approximately 1370 feet,
thence south for approximately 180 feet,
thence east northeast for approximately 1350 feet,
thence south for approximately 2700 feet to the south border of Section 28, T46N, R10E (3rd principal meridian),
thence east along the south border of Section 28, T46N, R10E (3rd principal meridian) to the east border of Section 33, T46N, R10E (3rd principal meridian),
thence south along east border of Section 33, T46N, R10E (3rd principal meridian) for approximately 150 feet,
thence northeast for approximately 100 feet to N. Deep Lake Rd,
thence north along N. Deep Lake Rd to W. Gelden Rd,
thence east along W. Gelden Rd to the east border of Section 27, T46N, R10E (3rd principal meridian)
thence south along the east borders of Section 27 & 34, T46N, R10E (3rd principal meridian) to the SW corner of NW ¼ Section 35, T46N, R10E (3rd principal meridian),
thence east along the south border of NW ¼ Section 35, T46N, R10E (3rd principal meridian) to the SE corner of NW ¼ Section 35, T46N, R10E (3rd principal meridian),
thence south along the east border of SW ¼ Section 35, T46N, R10E (3rd principal meridian) for approximately 1145 feet,
thence east to the shoreline of Lake Linden,
thence south for approximately 260 feet along the shoreline of Lake Linden,
thence southwest approximately 135 feet,
thence south approximately 150 feet to Sprucewood Ln,
thence continuing south approximately 1160 feet to the south section line of Section 35, T46N, R10E (3rd principal meridian)
thence east for approximately 870 feet to Witchwood Ln,
thence southeast along Witchwood Ln to Laurel Dr,
thence south along Laurel Dr to Countryside Ln,
thence southwest along Countryside Ln to Woodlane Dr,
thence southeast along Woodlane Dr to Valley Dr,
thence southwest along Valley Dr to E. Sand Lake Rd,
thence west along E. Sand Lake Rd to E. Grand Av,
thence southwest for approximately 550 feet,
thence south for approximately 3700 feet,
thence east for approximately 550 feet,
thence south and southwest for approximately 2550 feet across Fourth Lake,
thence west for approximately 4200 feet,
thence east northeast to the terminus of S. Nathan Hale Dr,
thence west for approximately 240 feet,
thence north for approximately 510 feet to N. Wildwood Dr,
thence south along N. Wildwood Dr for approximately 500 feet,
thence northwest for approximately 500 feet to the terminus of N. Fox Chase Dr,
thence west approximately 128 feet along N. Fox Chase Dr,

thence northwest and north for approximately 410 feet,
thence west for approximately 830 feet,
thence north for approximately 400 feet to W. Park Dr,
thence west along W. Park Dr to N. Tedy Ln.
thence south along N. Tedy Ln for approximately 210 feet,
thence west for approximately 140 feet,
thence southwest for approximately 350 feet,
thence north for approximately 320 feet,
thence west for approximately 700 feet,
thence south for approximately 370 feet,
thence west and northwest for approximately 1225 feet to the terminus of N. Mary Ct,
thence south west approximately 635 feet Milwaukee Av,
thence north along Milwaukee Av to W. Monaville Rd,
thence northwest and west along W. Monaville Rd to a point 1300 feet east of N. Cedar Lake Rd,
thence south for approximately 3000 feet,
thence west for approximately 1300 feet to N. Cedar Lake Rd,
thence south along N. Cedar Lake Rd to the Lake Villa / Avon Twp border,
thence west along the Lake Villa / Avon Twp border to the Avon / Grant Twp border,
thence south along the Avon / Grant Twp border to W. Rollins Rd,
thence west along W. Rollins Rd to W. Rollins Rd (extended),
thence continuing west along W. Rollins Rd (extended) to Squaw Creek,
thence generally west along the south Squaw Creek shoreline to North Duck Lake Channel,
thence south along North Duck Lake Channel to the west border of SW ¼ Section 14, T45N, R9E (3rd
principal meridian),
thence south along the west border of SE ¼ Section 14, T45N, R9E (3rd principal meridian) and continuing
south along the west border of NE ¼ Section 23, T45N, R9E (3rd principal meridian) to W. Big Hollow Rd,
thence west along W. Big Hollow Rd to a point approximately 100 feet past N. Oakside St,
thence south for approximately 375 feet,
thence east for approximately 150 feet,
thence south for approximately 75 feet,
thence west for approximately 150 feet,
thence south for approximately 75 feet,
thence east for approximately 150 feet,
thence south for approximately 425 feet,
thence southeast for approximately 425 feet to the shoreline of Wooster Lake,
thence to the south shoreline of Wooster Lake at a point approximately 1780 feet north of the south
border of Section 23 T45N, R9E (3rd principal meridian),
thence south to the south border of Section 23 T45N, R9E (3rd principal meridian),
thence east along the south border of Section 23 T45N, R9E (3rd principal meridian) to N. Wilson Rd,
thence south along N. Wilson Rd to W. Nippersink Rd,
thence west along W. Nipersink Rd to N. Fish Lake Rd,
thence south along N. Fish Lake Rd to the Grant / Wauconda Twp border,
thence east along the Grant / Wauconda Twp border Belvidere Rd,
thence northeast for approximately 4000 feet to Wilson Rd at a point approximately 400 feet north of
the southeast corner of Grant Twp,
thence south along the Wauconda / Fremont Twp border to the southeast corner NE ¼ Section 13,
T44N, R9E (3rd Principal meridian),

thence west along the south border of NE ¼ Section 13, T44N, R9E (3rd Principal meridian) to N. Gossell Rd,
thence northwest along N. Gossell Rd to N. Virginia Ln,
thence south and west along N. Virginia Ln to N. Garland Rd,
thence south along N. Garland Rd to W. Bonner Rd,
thence west along W. Bonner Rd to the southeast corner of N ½ Section 22, T44N, R9E (3rd principal meridian),
thence west along the south border of N ½ Section 22, T44N, R9E (3rd principal meridian) to N. Darrell Rd,
thence north along N. Darrell Rd to Neville Rd,
thence west along Neville Rd to Dowell Rd,
thence west for approximately 1100 feet to the Lake / McHenry County border,
thence south along the Lake / McHenry County border to Cardinal Ct, thence west for approximately 760 feet to Spruce Terrace,
thence northwest for approximately 500 feet,
thence south for approximately 1300 feet to W. Burnett Rd,
thence west along W. Burnett Rd to S. River Rd,
thence north along S. River Rd for approximately 30 feet,
thence west running parallel to the north borders of Sections 19 & 20, T44N, R9E (3rd principal meridian), to the Fox River,
thence southwest to a point approximately 520 feet from the shoreline of the Fox River,
thence southwest approximately 200 feet to the intersection of Nish Rd and IL Rt 176,
thence west along Nish Rd to Valley View Rd,
thence south along Valley View Rd to IL Rt 176,
thence southwest along IL Rt 176 to Smith Rd,
thence south along Smith Rd for approximately 850 feet,
thence northeast for approximately 2200 feet,
thence southeast for approximately 2000 feet to E. Terra Cotta Av,
thence west along E. Terra Cotta Av to Mistwood Ln,
thence south along Mistwood Ln to Savannah Ln,
thence west along Savannah Ln for approximately 150 feet,
thence south for approximately 2000 feet to E. Crystal Lake Av,
thence west along E. Crystal Lake Av for approximately 330 feet,
thence southwest for approximately 850 feet to Pingree Rd,
thence north for approximately 850 feet along Pingree Rd to Terra Cotta Rd,
thence west for approximately 300 feet,
thence south for approximately 850 feet to E. Crystal Lake Av,
thence west along E. Crystal Lake Av to N. Main St,
thence north along N. Main St to Brink St,
thence northwest along Brink St to N. Williams St,
thence southwest along N. Williams St to E. Crystal Lake Av,
thence east along E. Crystal Lake Av to S. Williams St,
thence south along S. Williams St to E. Franklin St,
thence west along E. Franklin St to McHenry Av,
thence south along McHenry Av to Rosedale Av,
thence southeast along Rosedale Av to College St,
thence southwest along College St to Grand Av,
thence east along Grand Av to 1st Ct,

thence south along 1st Ct to Union St,
thence west along Union St to McHenry Av,
thence southwest along McHenry Av to Pierson St,
thence northwest along Pierson St to Dole Av,
thence southwest along Dole Av to Leonard Pkwy,
thence southeast for approximately 950 feet along Leonard Pkwy (extended) to Ringling Rd,
thence south along Ringling Rd to Spruce Ln,
thence south along Spruce Ln to Golf Rd,
thence west along Golf Rd to Country Club Rd,
thence west along Country Club Rd to the south border of Section 1, T43N, R7E (3rd principal meridian),
thence west along the south border of Section 1, T43N, R7E (3rd principal meridian) to Huntley Rd,
thence north approximately 250 feet on Huntley Rd,
thence west approximately 1300 feet,
thence south approximately 260 feet to the south border of Section 1, T43N, R7E (3rd principal meridian),
thence west along the south border of Section 1, T43N, R7E (3rd principal meridian) to approximately 40 feet west of the west border of Section 1, T43N, R7E (3rd principal meridian)
thence north running parallel along the west border of Section 1, T43N, R7E (3rd principal meridian) for approximately 1300 feet,
thence west to the west border of Section 2, T43N, R7E (3rd principal meridian),
thence north along to the west border of Section 2, T43N, R7E (3rd principal meridian) to approximately 100 feet south of the Dorr / Grafton Twp border,
thence west running parallel to the Dorr / Grafton Twp border to the southwest corner of Section 34, T44N, R7E (3rd principal meridian),
thence generally north along the west borders of Section 34, 27, 22, 15 T44N, R7E (3rd principal meridian) to US Rt 14,
thence southeast along US Rt 14 to Lily Pond Rd,
thence north along Lily Pond Rd and Lily Pond Rd (extended) to McConnell Rd,
thence west along McConnell Rd to Sanctuary Dr,
thence north along Sanctuary Dr to Fairview Circle,
thence south approximately 300 feet,
thence east approximately 150 feet,
thence northeast approximately 670 feet,
thence northwest approximately 370 feet,
thence west approximately 400 feet to Hillcrest Rd,
thence north along Hillcrest Rd to W. Longwood Dr,
thence north along W Longwood Dr to Ridgemoor Trail,
thence northwest along Ridgemoor Trail to Oakmont Dr,
thence west along Oakmont Dr to Bull Valley Dr,
thence west along Bull Valley Dr to Club Rd,
thence north along Club Rd to Bull Valley Rd,
thence north along Bull Valley Rd to S. Queen Anne Rd,
thence north along S. Queen Anne Rd to N. Queen Anne Rd,
thence north along N. Queen Anne Rd to approximately 165 feet north of the Greenwood / Dorr Twp border,
thence east running parallel to the Greenwood / Dorr Twp border to approximately 150 feet west of the Greenwood / McHenry Twp border,
thence north running parallel to the Greenwood / McHenry Twp border to IL Rt 120,

thence east along IL Rt 120 to E. Wonder Lake Rd,
thence north along E. Wonder Lake Rd to the north border of Section 19, T45N, R8E (3rd principal meridian),
thence east along the north borders of Sections 19, 20, 21 T45N, R8E (3rd principal meridian) to N. Ringwood Rd,
thence south along N. Ringwood Rd to Florence Blvd,
thence southeast approximately 1000 feet to a point approximately 75 feet east of the intersection of N. Ringwood Road and W. Flanders Rd,
thence west on W. Flanders Rd to N. Ringwood Rd,
thence south along N. Ringwood Rd to approximately 50 south of the south border of Section 21, T45N, R8E (3rd principal meridian),
thence west along the south border of Section 21, T45N, R8E (3rd principal meridian) to Dot St (extended),
thence south along Dot St (extended) and continuing south along Dot St to W. Elm St,
thence southeast along W. Elm St to N. Curran Rd,
thence south along N. Curran Rd to N. Draper Rd,
thence west for approximately 800 feet,
thence north for approximately 145 feet,
thence west for approximately 540 feet,
thence north for approximately 400 feet,
thence west for approximately 300 feet,
thence south for approximately 300 feet,
thence west for approximately 325 feet,
thence southwest for approximately 950 feet to the east border of Section 29, T45N, R8E (3rd principal meridian),
thence south along the east border of Section 29, T45N, R8E (3rd principal meridian) (and N. Curran Rd) for approximately 1700 feet,
thence east for approximately 6000 feet to the unnamed creek,
thence south along the unnamed creek for approximately 3000 feet to a point west of Kensington Dr,
thence east to Kensington Dr,
thence south along Kensington Dr to Waters Edge Dr,
thence south along Waters Edge Dr to W. Dartmoor Dr,
thence west along W. Dartmoor Dr to N. Huntington Dr,
thence south along N. Huntington Dr to W. Sarasota Dr,
thence east along W. Sarasota Dr to Augusta Dr,
thence south along Augusta Dr to W. Greenbriar Dr,
thence west along W. Greenbriar Dr to S. Heritage Dr,
thence south along S. Heritage Dr to a point approximately 90 feet north of W. Malibu Ct,
thence east to N. River Rd,
thence north along N. River Rd to Chapel Hill Rd,
thence northeast along Chapel Hill Rd to Julia Way,
thence east for approximately 100 feet,
thence north for approximately 600 feet to approximately 60 feet north of the south border of Section 19, T45N, R9E (3rd principal meridian),
thence east running parallel to the south border of Section 19, T45N, R9E (3rd principal meridian) to W. Reiche Ln,
thence north along W. Reiche Ln to N. Marquardt Ln,
thence north along N. Marquardt Ln to W. August Ln,

thence east along W. August Ln to N. Long Ln,
thence north along N. Long Ln to the terminus of N. Long Ln,
thence east for approximately 250 feet,
thence north for approximately 2700 feet to Bay Rd,
thence west along Bay Rd to Chapel Hill Rd,
thence north along Chapel Hill Rd to the Fox River,
thence northeast along the Fox River to the McHenry / Lake County border,
thence north along the McHenry / Lake County border to the Soo rail line,
thence northwest along the Soo rail line for approximately 200 feet,
thence southeast along the Soo rail line for approximately 200 feet,
thence northwest for approximately 180 feet,
thence southwest for approximately 180 feet,
thence southwest to approximately 35 feet north of the Burton / McHenry Twp border,
thence west running parallel to the McHenry / Burton Twp border to the Burton / Richmond Twp border,
thence north along the Burton / Richmond Twp border to Main Street Rd,
thence west along Main Street Rd and continuing west along E. Solon Rd to the west border of E ½ Section 23, T46N, R8E (3rd principal meridian),
thence north along the west border of E ½ Section 23, T46N, R8E (3rd principal meridian) to the north border of Section 23, T46N, R8E (3rd principal meridian),
thence west along the north border of Section 23, T46N, R8E (3rd principal meridian) to N. Solon Rd,
thence north along N. Solon Rd to IL Rt 173,
thence east along IL Rt 173 to Lakeview Rd,
thence north along Lakeview Rd to Lincoln Ave,
thence northwest to a point approximately 165 feet west of the intersection of Lakeview Rd in McHenry County and the Illinois / Wisconsin border, which is the point of beginning.
