

Representative District 51 shall include that part of Illinois beginning at the intersection of Wilson Rd. and West Townline Rd. in Fremont Twp. in Lake County, thence east to the Libertyville Twp. line (US Hwy. 45), thence continuing east following US Hwy. 45 to North Milwaukee Ave. (Warren Twp.), thence northeast to Belvidere Rd., thence northeast to O'Plaine Rd., thence south to the Libertyville Twp. line (O'Plaine Rd.), thence continuing south following O'Plaine Rd. to Buckley Rd., thence southwest to St. Marys Rd., thence southwest and south following St. Mary's Rd. to West Old School Rd., thence west approximately feet following West Old School Rd. to Des Plaines River, thence northwest following the Des Plaines River to Red Top Dr. extended, thence southwest following Red Top Dr. extended to Red Top Dr., thence southwest to Kempton Dr., thence northwest to Florsheim Dr., thence generally west following Florsheim Dr. to Artaius Pky., thence south and southwest following Artaius Pky. to South Milwaukee Ave., thence northwest to Greggs Pky., thence west and northwest following Greggs Pky. to Huntington Dr., thence north, northwest and west following Huntington Dr. to South Butterfield Rd., thence southwest and south following South Butterfield Rd. to Allanson Rd., thence west to South Lake St., thence northwest to the Fremont Twp. line, thence southwest, west, southeast, southwest and south following the Fremont Twp. line (Diamond Lake Rd.) to the Ela Twp. line, thence continuing south following the Ela Twp. line to Indian Creek Rd. extended (Vernon Twp.), thence east to Il. Rt. 83, thence south and southeast following Il Rt. 83 to Port Clinton Rd., thence east, southeast and east following Port Clinton Rd. to the Long Grove Corp. limits, thence south to Il. Rt. 22, thence east following Il. Rt. 22 to the Long Grove Corp. limits, thence south, west, southeast, south, northwest, west, south, east, south, southeast and south following the Long Grove Corp. limits to Aptakisic Rd., thence west to the Long Grove Corp. limits, thence south, east, south and west following the Long Grove Corp. limits to North Arlington Heights Rd., thence south to Fremont Way, thence west to Bristol Ln., thence north, northwest, west and northwest following Bristol Ln. to Franklin Ln., thence southwest to Fremont Way, thence northwest to Farnsworth Ln., thence northeast to Bristol Ln., thence west and southwest following Bristol Ln. to Fremont Way, thence southeast to Fairfax Ln., thence generally south following Fairfax Ln. to the Long Grove Corp. limits,

thence generally southwest, south and east following the Long Grove Corp. limits to Carlton Pl. extended,
thence east to Arlington Heights Rd.,
thence south, southwest and south following Arlington Heights Rd. to Rfd,
thence west to the Long Grove Corp. limits,
thence generally south following the Long Grove Corp. limits to the Vernon Twp. line (Lake Cook Rd.),
thence west, southwest and west following Lake Cook Rd. to the Palatine Twp. line in Cook County (North Wilke Rd.),
thence south to the Arlington Heights Corp. limits,
thence west and north following the Arlington Heights Corp. limits to Trail Ridge St.,
thence west to North Galesburg Ave.,
thence north to the Arlington Heights Corp. limits,
thence west to North Bloomington Ave.,
thence south to Nichols Rd.,
thence west to Queensburg Ln.,
thence south to North Williamsburg Dr.,
thence southwest and west following North Williamsburg Dr. to Old Hicks Rd.,
thence north, northwest, west and north following Old Hicks Rd. to Lake Cook Rd. (Ela Twp. in Lake County),
thence west to the Ela Twp. west line,
thence north to the Fremont Twp. line,
thence continuing north following the Fremont Twp. line (Wilson Rd.) to the place of beginning.
